PPI ratings to the shoulder and hip are to be to the body as a whole

Loss by separation of both hands, both feet, or total sight of both eyes, or any two such losses in the same accident entitle claimant to 100 degrees of impairment

For amputations, the dollar values per degree are multiplied by two. This doubling does not apply to loss of use that is not a loss by separation.
